By now you should be aware that ARRL has had a bill introduced in the House and Senate requiring the FCC to study the "interference potential" of BPL. These are H.R. 462 and S 1629 both named "The Emergency Amateur Radio Interference Protection Act of 2007. 2007 Field Day Flash Back

In the early summer, lots of time was spent getting the club's laptops ready for Field Day 2007 held on Saturday, June 23rd and Sunday, June 24th at Harbor Island Park in Mamaroneck, NY. This year we setup at the beach pavilion structure located along the south-eastern part of the park. Setup began at 9am on Saturday; radio operations began at 2pm and went through the night finishing at 2pm on Sunday. Many hands were needed for setup on Saturday and tear down on Sunday - we finished at about 3pm - a new record!

This year WECA had four transmitters (4A) on HF, a VHF 6 meter station, and a GOTA station (to introduce people to the many facets of Ham Radio). There were many types of antennas used: beams, dipoles, verticals, long wires, etc. And of course many types of radios, including a continuous demonstration of APRS and some experimental gear.

For this year's Field Day we used five of the WECA laptops and a small "touch-screen" server in a wired network to track our performance and contact information from the Field Day exercise. The setup time only took 30 minutes! User's reports were very positive stating that the network and software operated well, was easy to use, and reliable!

Our claimed score submitted to the ARRL was 4,780 points - nice job! The results should be published soon in QST magazine.
